SITE SAFETY ORIENTATION

INTRODUCTION

Because every construction project is different, and each presents its own hazards we want to orientate ourservies with this site.



In our meeting we will discuss:

- (1) EMERGENCY PROCEDURES
- (2) SITE SAFETY DOCUMENTATION / MEETINGS
- (3) PPE REQUIREMENTS

EMERGENCY PROCEDURES

FIRE / EARTHQUAKE: In the event this should occur and there is need to evacuate, an air horn will give three long blasts. (Note to conductor: If you have another means to signal an evacuation, mention what it is).

If you hear this, get out of any hazardous area and safely make your way to the emergency staging area. (Note: Identify where the location is at for this current site).

Wait there until you are accounted for. Do not return to work unless emergency services and site management has autorized it.

MEDICAL EMERGENCY: In the event you are injured and it is an emergency, have someone call 911. If you are injured and it is not an emergency, you will be given the name of a medical facility to receive treatment.

FIRST AID KIT / FIRE EXTINGUISHERS: These are kept on site and are only to be used if you are trained to do so.

SITE SAFETY DOCUMENTATION / MEETINGS

COMPANY SAFETY PROGRAM: A copy of this is kept on site and available for your review.

SAFETY DATA SHEETS (SDS): We keep data sheets on all chemicals we have on site. Never use a chemical unless you have been trained on how to use it. Do not transfer a chemical from one container to another unless you ar trained and know how to label the secondary container. You are welcome to access the SDS anytime.

SAFETY MEETINGS: We will be holding safety meetings regularly. Your attention and input are inportant to ensuring our job is kept safe.

JOB HAZARD ANALYSIS (JHA): We prepare these for certain tasks. They identify specific steps of a task, the hazards involved, and how to perform the task safely.

PPE REQUIREMENTS

HARD HATS: These are to be worn at all times while on the construction site. Any exceptions must first be cleared with site supervision.

EYE PROTECTION: Must be labeled ANSI Z-87 and be worn at all times. Any exceptions must first be cleared with site supervision.

CLOTHING / BOOTS: Work boots, long pants, and shirts with sleeves must be worn.

OTHER PPE: There are other forms of PPE that you may need to wear after you are trained. This includes hearing protection, respiratory protection, hand protection, hi visibility clothing, and fall protection.
