	A Mitchell employee is using an A-Frame ladder in a closed position. Another Mitchell employee is using an A-Frame ladder that is not level.	Please ensure employees use A-Frame ladders in an open, locked, and level position. Likely an extension ladder would be a better option for the circumstances pictured.
	This ramp exceeds the maximum angle allowed of 1 foot of rise for 12 feet of horizontal run.	It is recommended that scaffold stairs are installed in another location as concrete stairs will be to be poured in the area pictured. As a general reminder, 2 sets of stairs must be installed prior to raising studs to the 3rd floor.
	Materials are being stored in a walkway.	The foreman assigned employees to move the materials. A path will be delineated using caution tape.
