	There has been improvement in what is posted. For example, the evacuation route, map to the nearest medical facility, emergency numbers, and Cal OSHA's Heat Illness poster have been provided.	Still pending are the Code of Safe Practices, Operating Rules for Industrial Trucks, and the entire Heat Illness Prevention Program.
	An employee is using a nail gun while not wearing safety glasses.	The employee complied to use his safety glasses.
	An employee is exposed to a fall hazard above 15' while installing guardrails.	When employees are performing framing activities they have an exception of 15' to implement fall protection. The employee has exceeded this height and is not using personal fall protection. Please ensure employees use personal fall protection when required.
	An employee has no access ladder setup. An employee brought an A-Frame ladder over, which required the employee to use the top 2 steps.	Please ensure an extension ladder is installed for access. The ladder must extend 36" above the platform being accessed, be secured, and installed at a 4:1 ratio.
	An employee is standing on the 2nd to top step of an A-Frame ladder, which is not allowed.	The employee complied to obtain a taller ladder.

An employee is sitting on the top cap of an A-Frame ladder, which is prohibited.	The employee complied to use the approved steps of the ladder.
Employee is using a STOP/SLOW paddle that is not equipped to a 6' staff.	STOP/SLOW paddles must be equipped to a 6' staff. Flaggers must be trained.
Cords and hoses running through walkways are creating tripping hazards.	Please ensure attention is given to housekeeping.
