This should include all areas of the site that pose safety hazards to include areas of fall exposure including but not limited to all floor/roof/ground openings and guardrails. All floor/roof/ground openings and guardrails shall be compliant with federal and state law.

CVC Concrete missing rebar caps on ground stakes/rebar, rebar caps needed anything under 6ft (Superintendent Carlos Escalera immediately took action and contacted subcontractor about missing rebar caps). McDaniel Construction Framers missing top guardrail on window opening on second floor, guardrails needed at 42 inches and 21 inches. All other trades were in compliance at the time of my visit. The site is well kept with good housekeeping.

CVC Concrete missing rebar caps on rebar.
