- One worker was reminded of the importance of wearing a hardhat when in the construction area. (corrected on the spot.)
- Air compressor was found with missing pulley guard which can result in entanglement hazards. (Kevin is having this corrected.)
- Live electrical outlets were observed without cover plates, which can lead to contact with exposed wires.
