- Multiple safety issues were observed with scaffolding (see suspended scaffolding below)
- Fall harness and lanyard are required inside of reach lift personnel basket used above height triggers.
- (Gonzalez.)
- Multiple outlet covers were missing on live electrical outlets. (See below for lot numbers)
- Temporary handrails were missing from stairwells.

- + Fire extinguisher was being inspected monthly and documented.
