- Door hardware install (Quality door)

Good items noticed:

- + Landscapers were cutting sidewalk concrete using water and respiratory protection to avoid silica exposure.
- + All extension cords were inspected and found in satisfactory condition.
- + All landscaping materials and plants on site are stacked neatly off to the side out of walkways etc.
- + The interior house is very clean and organized
- + Exterior was clean and free of obstructions
- + Daily site inspections are being documented through use of the safety app.
- + Labor law posters are mounted in plain sight on fence

Safety Concerns:

- Safety documentation needs to be maintained on site in the event of an emergency. This would include such items as emergency contact numbers, hospital/urgent careroute map, water replenishment form, etc.

- Live electrical outlets were left pulled and exposed. This presents an electrical shock hazard due to live exposed wiring.

- Missing outlet and light switch covers were observed. This presents an electrical shock hazard due to live exposed wiring.

* Exposed Electrical Parts:

Missing covers and free access to exposed energized electrical parts must be replaced. These dangers can easily be eliminated by replacing missing covers to electrical panels, boxes and outlet by covering the openings that have unrestricted access to exposed energized electrical parts and preventing the danger of shock and electrocution.
