Documentation: All required safety documentation, including the Safety Program, Safety Data Sheets, and labor law postings, were up to date and on site.

Emergency Items: Fire extinguishers were inspected monthly and found to be in good condition. First aid kits were also stocked and available.

General Site Conditions: Restrooms, hand washing stations, waste containers, and potable water were all satisfactory. The building provided adequate shade for workers.

Tools & Equipment: Power tools, hand tools, and pneumatic nailers were in good condition. Cylinder storage was compliant.

Unsatisfactory Items:

Ladders: Some ladders had worn-off labels and need replacements with legible labels.

Guardrails: The second floor had a loose upright post, and the third floor lacked proper railing. Missing or incomplete guardrails in other areas need to be installed.

Floor/Wall Openings: Some openings lacked mid-rails or guardrails. Guardrails need to be set at 42-45 inches with proper mid-rails.

Other Areas: Supported scaffolding, impalement hazards, traffic control, and electrical safety were satisfactory. Housekeeping was noted as well-maintained.
